Re: Floyds Knobs Water Company, Inc. (FKWC)

Submission of Thirty Day Administration Filing (170 IAC 1-6)

I'm writing as attorney for Floyd Knobs Water Company, Inc. (FKWC/ "the Utility").

Being submitted is a filing pursuant to Rule 6 of Article 1 of Title 170 of the Indiana Administrative Code (Thirty-Day Administrative Filing Procedures and Guidelines).

The Utility is requesting the following:

1. A change in the charge imposed for a new connection supplied thru a  $\frac{3}{4}$  inch meter. The present charge (IURC approved 6/22/2016) is \$1,350, plus the actual cost of any required highway or road permits.

The Utility is requesting the subject charge be changed to \$1,885 for a connection not requiring the removal and replacement of roadway pavement, and \$4,070 for a connection requiring the removal and replacement of roadway pavement.

2. The addition of the following non-recurring charges to the Utility's Schedule of Rates and Charges:

(a) Reconnection Charge - \$59.10

When a service is turned off for nonpayment of a bill, or if for any reason beyond the control of the utility a reestablishment of service is required, this charge will be made by the utility for the discontinuance and, if requested by the member, reestablishment of service. This charge, together with any arrears due, must be received by 4:00pm to restore service the same day.

(b) Reconnection Surcharge - \$15.00

This charge will be made in addition to the \$59.10 reconnection charge for reestablishment of service on Saturday, Sunday, holidays and before 8:00am and after 4:00pm on weekdays.

(c) Reinstallation/ Lock Surcharge - 59.10

When a meter has been removed or locked following service disconnection due to unauthorized use of the service and/or meter by the member, there shall be an assessed a surcharge for the removal or locking and reinstallation of the meter. This charge as well as any cost for materials needed for repairs shall be in addition to the applicable reconnection charge and/or reconnection surcharge.

(d) General Service Charge - \$59.10

This charge will be made for any trip to a member's premises, at the member's request, for conditions on the customer's responsibility side of the meter during the period of 8:00am - 4:00pm weekdays.

(e) General Service Surcharge - \$15.00

This charge will be made in addition to the \$59.10 general service charge for such service on Saturday, Sunday, holidays, and before 8:00am and after 4:00pm weekdays.

(f) Returned Check and Online Payment Charge - \$50.00

This charge will be made for each instance that a check or bank drafting issued in payment is returned to the utility by the depository bank, such check or drafting not having been honored by the bank for any reason. Online payments and ACH payments returned for insufficient funds shall have charge applied.

(g) Collection and Deferred Payment Charges.

All bills for water not paid by the due date stated on a bill, (the due date being not less than 17 days after the date a bill is mailed, are subject to a collection or deferred payment charge of ten percent (10%) on the first \$3.00 and three percent (3%) on the excess over the \$3.00.

(h) Start- Up (Non Refundable) - \$50.00

---

The Start-Up Fee shall be paid in addition to the membership fee and/or connection charge, upon application for membership in this company and is non-refundable. New members shall pay this fee to cover the administrative and maintenance costs associated with activating an account.

(i) Postage Charge-Delinquent Accounts - \$0.50

---

\*At any time a delinquent billing for water services is required to be mailed, an additional charge of \$0.50 (fifty-cents) shall be made for postage.

The requested connection charge change is needed as a result of general cost increases, including costs for labor and materials, since the present charge was approved in 2016. Additionally, the requested change is needed in recognition of the substantial increase costs related to a connection requiring the removal and replacement of pavement, versus a connection that does not.

The requested additional charges are needed to properly generate sufficient revenue to cover costs required to provide basic services. The requested additional charges are in line with charges imposed by other IURC regulated water utilities in the general vicinity of FKWC.

The requested connection charge change, and the requested additional charges, are allowable under Section 3 of 170 IAC 1-6, as nonrecurring charges.

(d) Connection Charges

- (1) Each user at the time of connection to the water works system shall pay a charge to cover the costs of: Excavating and tapping the main; furnishing and installing service pipe from the main to the customer's line; furnishing and installing corporation stop; and furnishing and installing meter well (if outside), yoke, and meter. The charge for a 3/4 inch meter connection shall be \$1,350.
- (2) The charge for a connection for a service with a meter larger than 3/4 inch shall be the actual cost of labor, materials, power machinery, transportation, and overhead incurred for making the connection, but not less than the charge for a 5/8 or 3/4 inch meter connection.
- (3) In addition to the charges set forth in sub-paragraphs 1 and 2 above, a connection charge shall include the actual cost of any required highway or road permits.

(e) Membership Fees

The membership fee shall be \$100.00.

(f) Temporary Users

Water furnished to temporary users such as contractors, circuses, etc., shall be charged on the basis of the metered gallon rates hereinbefore mentioned set forth as estimated and established by the waterworks superintendent.

(g) Collection and Deferred Payment Charges

All bills for water services not paid within fifteen (15) days from the due date thereof, as state in such bills, shall be subject to the collection or deferred payment charge of 10% on the first \$3.00 and 3% on the excess of \$3.00.

(d) Membership Fees

The membership fee is \$100.00.

(e) Initial Administrative Charge

New members/customers are charged \$50 upon an initial request to become a member/customer, to cover administrative costs related to establishing an account.

(e) Connection Charges

- (1) If the connection is to a main located under pavement, the charge for a  $\frac{3}{4}$  inch meter connection (excavating and tapping the main; furnishing and installing service pipe from the main to the meter location; furnishing and installing a "stop"; and furnishing and installing the meter well, yoke, and meter) is \$4,070.
- (2) If the connection is to a main not located under pavement, the charge for a  $\frac{3}{4}$  inch meter connection (excavating and tapping the main; furnishing and installing service pipe from the main to the meter location; furnishing and installing a "stop"; and furnishing and installing the meter well, yoke, and meter) is \$1,885.
- (3) The charge for a connection for a service with a meter larger than  $\frac{3}{4}$  inch shall be the actual cost of labor, materials, power machinery, transportation, and overhead incurred for making the connection, but not less than the charge for a  $\frac{5}{8}$  or  $\frac{3}{4}$  inch meter connection.
- (4) In addition to the charges set forth in sub-paragraphs 1 and 2 above, a connection charge shall include the actual cost of any required highway or road permits.

(f) Reconnection Charge(s)

A reconnection charge of \$59.10 is imposed any time a service has been turned off for nonpayment of a bill, or if for any reason beyond the control of the utility a reestablishment of service is required. Payment must be made by 4:00 p.m. for the service to be turned on the same day. Also, a surcharge of \$15.00 is imposed if the reestablishment of service happens on a Saturday, Sunday, holiday, or before 8:00 a.m. or after 4:00 p.m. on week days.

(g) Reinstallation / Unlock Surcharge

If a meter has been removed, or locked, as a result of unauthorized use, \$59.10 is charged for reinstallation or unlocking. This charge is in addition to the reconnection charge(s) set forth in section (e) above.

(h) General Service Charge(s)

A charge of \$59.10 is imposed for any trip to a member/customer's premises, at the member/customer's request, to investigate conditions on the member/customer's side of the meter. An additional \$15 charge is imposed if the trip is made on a Saturday, Sunday, holiday, or before 8:00 a.m. or after 4:00 p.m. on a weekday.

(i) Delinquent Payment Charge

Bills not paid by the due date stated on the bill (the due date being not less than 17 Days after the bill is mailed) are subject to a delinquent payment charge of ten percent of the first \$3.00. and three percent of the amount of the bill in excess of \$3.00.

( ) Notice of Delinquency / Postage Charge

\$0.50 is charged for mailing a notice of delinquency.

(j) Returned Check / Declined Payment Charge

A \$50 charge is imposed if a payment check is returned by the payor's bank, or if an online or ACH payment fails.

(f) Temporary Users

Water furnished to temporary users such as contractors, circuses, etc., shall be charged on the basis of the metered gallon rates hereinbefore mentioned set forth as estimated and established by the waterworks superintendent.

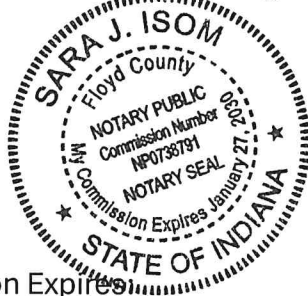


